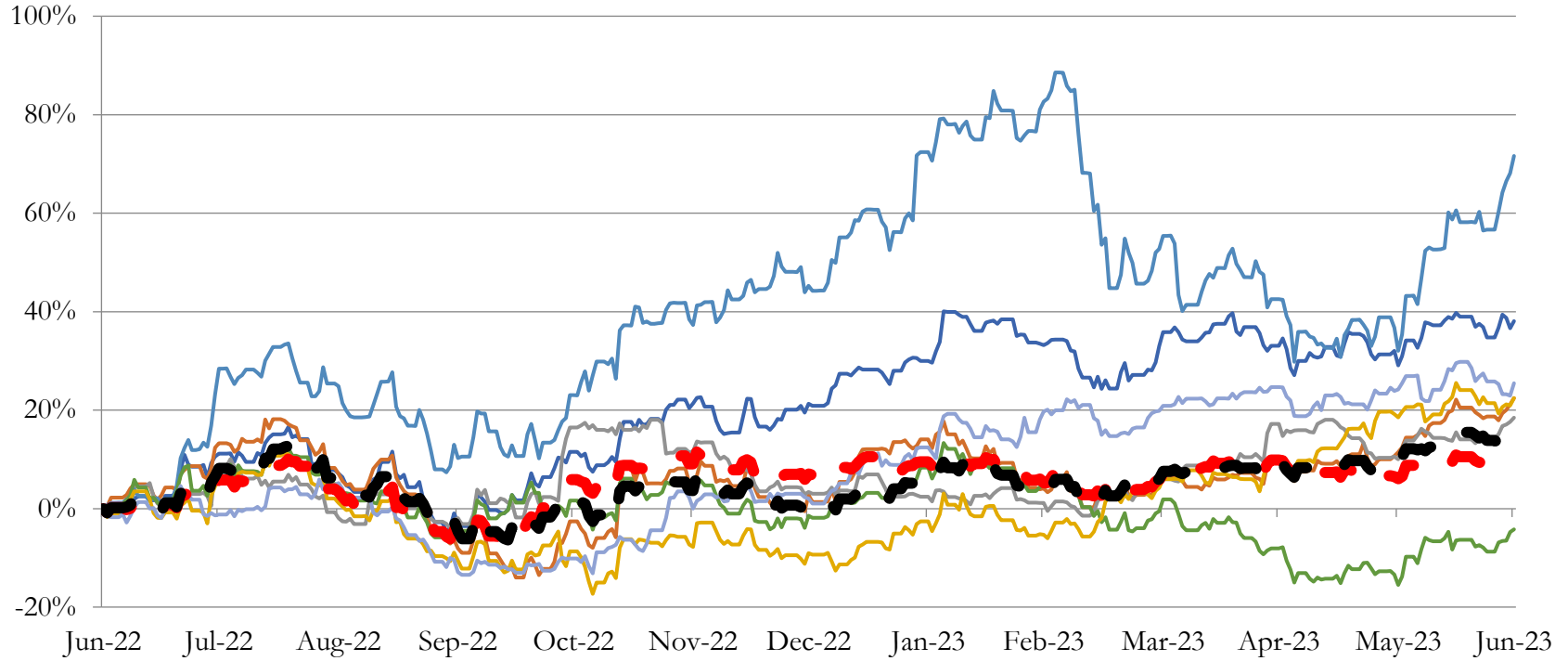

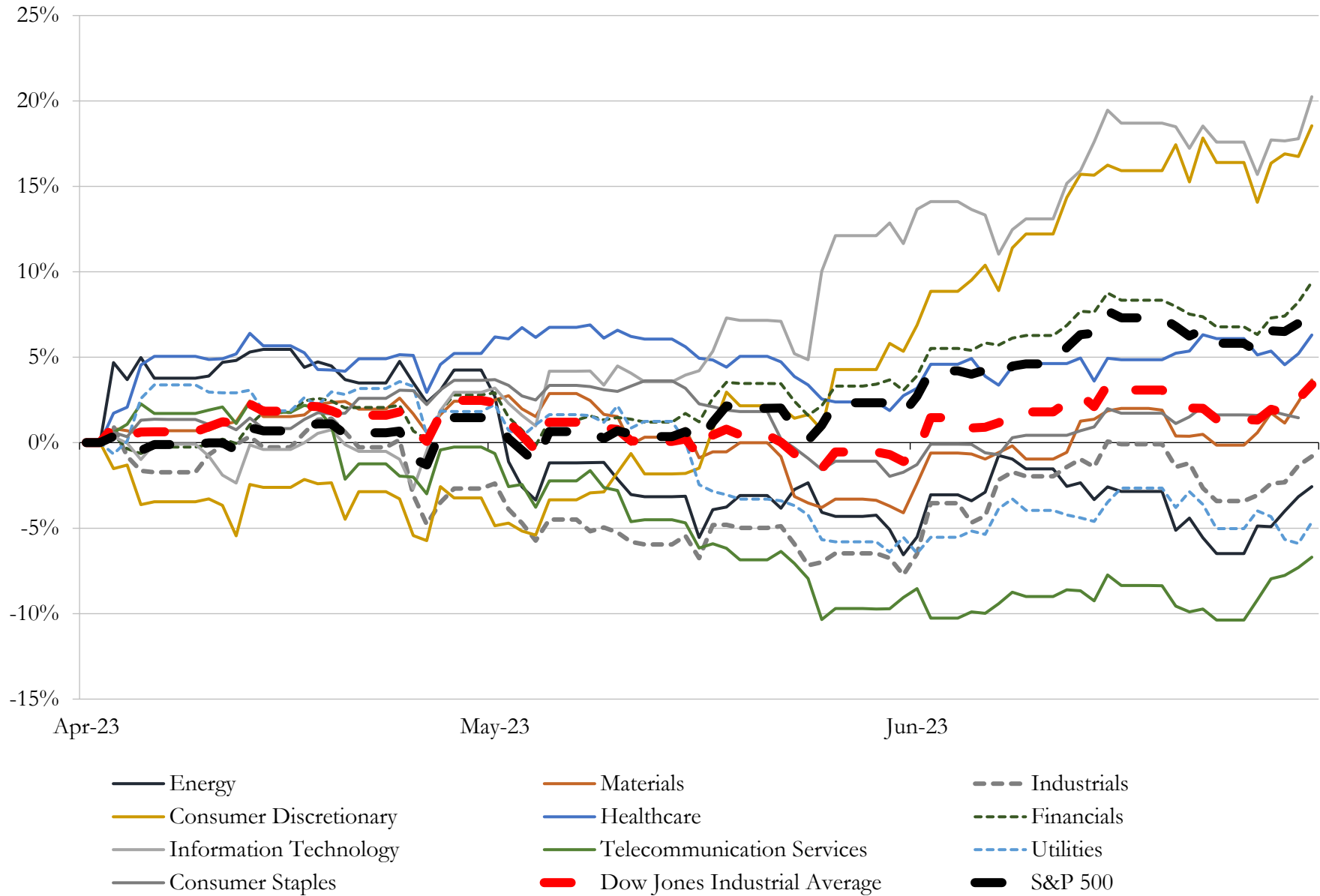

Last Three (3) Months as of June 30, 2023

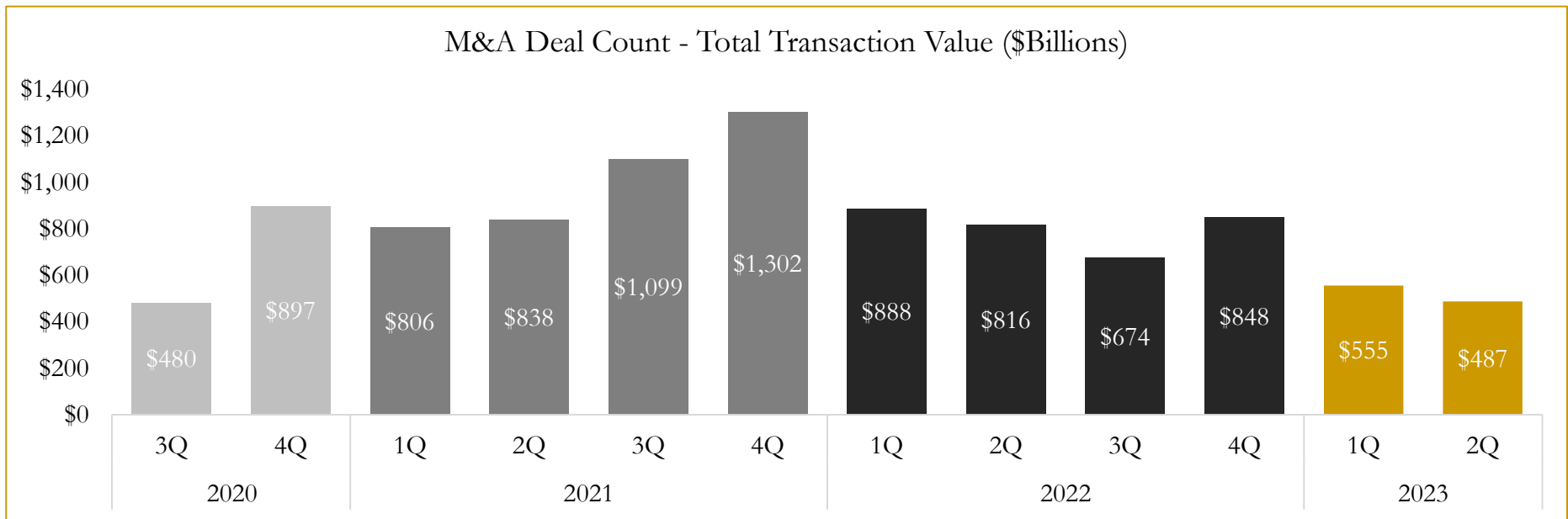
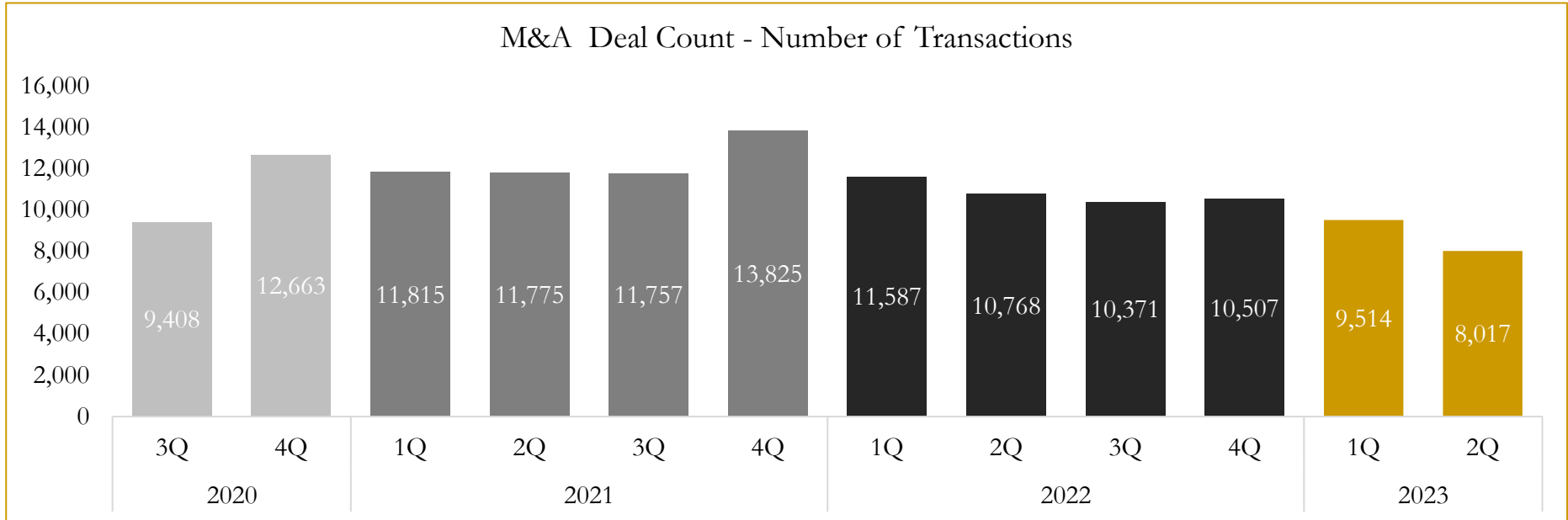
